1. Response of acceptance by **Friday, June 14, 9:00 a.m. (JST)**

All successful applicants must respond.

Even if you withdraw from the application, your response is still required, so please be sure to respond by the deadline.

If you do not respond by the deadline, in principle, we will consider your application as withdrawn.

2. Payment of Research Incentives (equivalent to living expenses)

The first payment is scheduled for Friday, July 19. Only the first payment will be for 4 months (from April to July), and monthly payments will be made from August onward.

If it is necessary to correct or confirm the transfer request form and a copy of the bankbook submitted at the time of application, we will contact you after receiving your approval, so please do so as soon as possible. Please note that the first payment may be delayed if the procedures are not completed in time.

3. Payment of Research funds

The issuance of budget codes, which are necessary for the use of research funds, is scheduled for late June.

In principle, you are required to purchase goods, etc. after the issuance of the budget code, but retroactive appropriation is possible for orders placed on or after June 17, 2024 (date of selection).

Please take all the training courses you are required to attend, as proper use of the research funds is required.

4. Participation in orientation for support students

The event is scheduled for late June or early July.

We will contact you as soon as details are finalized.

5. Sharing with relevant parties

Please be sure to inform your academic supervisor who will be responsible for executing the budget.

If you are being treated as a dependent by a person who is obligated to support you (such as a parent) for health insurance, support allowance, etc., in principle, you need to be removed as a dependent. Please be sure to contact the person who is obligated to support you.
